

# **Under 18s Un-Accompanied Agreement**

Boathouse Climbing Centre understand and recognise that some under 18s are more than capable of looking after themselves or be able to climb with friends without adult supervision or an instructor.

We must put steps in place that ensure the safe use of the facilities, and all parties must understand their position. This form outlines who can apply and the rules to follow.

Please complete all of the fields highlighted in red.

# Who Can Apply

- 1. Any Under 18 that is an experienced climber (assessment needed)
- 2. Under 18's who are a Junior Crew Member and have been attending a club for a full term
- 3. Under 18's who are a member of another climbing academy / club (assessment needed)

#### **Rules**

The standard centre rules must be read and understood and adhered to at all times. Only 1 warning will be verbalised to the under 18 per session. A 2<sup>nd</sup> will be simply 'please leave the centre!' If this happens on more than 3 occasions this agreement will no longer apply, and the under 18 will not be able to climb unaccompanied at Boathouse Climbing Centre.
